Subject: Nominations for the appointment of Vigilance Commissioner under the Jammu and Kashmir State Vigilance Commission Act, 2011.



Accordingly, all Administrative Secretaries are requested to submit fresh nominations for consideration against the vacant position of Vigilance Commissioner in the Jammu and Kashmir State Vigilance Commission. The nominations should reach the General Administration Department by or before **20.01.2019**, beyond which no nomination shall be entertained.

4. It is clarified that the persons nominated by the departments in response to OM dated 18.5.2018 need not be recommended again.

Subject: Nominations for the appointment of Vigilance Commissioner under Jammu and Kashmir State Vigilance Commission Act, 2011.

01. Nominations are hereby invited from all Administrative Secretaries for the appointment against the vacant post of Vigilance Commissioner in the J&K State Vigilance Commission by **30.05.2018**. **No nomination shall be received after the cutoff date.** No application will be entertained by the General Administration Department directly from any applicant.

02. Section 3(3) of the J&K State Vigilance Commission (Amendment) Act, 2011 provides that the Vigilance Commissioner shall be appointed from amongst persons who have been or are in All India Service or in any Civil Service of the State or in a civil post under the State having knowledge and experience in the matters relating to vigilance, law, finance, policy making and administration including police administration.

03. The GAD vide notification dated 29.12.2011 has already issued guidelines regarding the appointment of CVC and VCs of J&K State Vigilance Commission keeping in view the order of the Hon'ble Supreme Court in P.J. Thomas Case. These guidelines are reiterated below:

- a. The incumbent would have to demit office upon attaining the age of 65 years or upon the completion of 4 years, whichever is earlier; the person recommended must at least have a minimum tenure of 3 years.
- b. The person should be of outstanding merit and impeccable integrity.
- c. While making a nomination, a note containing reasons why in the opinion of the forwarding/sponsoring authority the person is considered to be suitable for appointment as a Chief Vigilance Commissioner/Vigilance Commissioner including merit and integrity should be made part of the nomination. In addition to the above, the following information may be made available:-

- i. The complete up-to-date curriculum vitae, including age, educational qualification and details of all posts held by the officer since the beginning of his/her career;
- ii. Service record, namely, Annual Confidential Reports;
- iii. Any additional record indicating conferment of honors/awards/additional qualifications/outstanding achievement;
- iv. Details of punishment, if any, awarded in the course of officer's service career;
- v. The Ministries/Departments would also indicate whether there exist any criminal cases/disciplinary proceedings against the officer concerned.
- vi. An integrity certificate to be issued by the cadre controlling authority.
- vii. Vigilance clearance report from Vigilance Organization or the Commission.

04. The names of persons of known impartiality may be forwarded for consideration and endeavor be made to nominate persons belonging to all the fields mentioned at para 02 above.

Subject: Guidelines for appointment of Chief Vigilance Commissioner and Vigilance Commissioners under Jammu and Kashmir State Vigilance Commission Act, 2011.

Section 3(3) of the J&K State Vigilance Commission (Amendment) Act, 2011 provides that the Chief Vigilance Commissioner and Vigilance Commissioners shall be appointed from amongst persons who have been or are in All India Service or in any Civil Service of the State or in a civil post under the State having knowledge and experience in the matters relating to vigilance, law, finance, policy making and administration including police administration.

02. After careful consideration and keeping in view the guidelines issued by Government of India pursuant to the direction of Hon'ble Supreme Court regarding appointment of Central Chief Vigilance Commissioner and Vigilance Commissioners it has been decided to seek names of persons for appointment as Chief Vigilance Commissioner and Vigilance Commissioners on the basis of the following parameters:-

- a. Any incumbent would have to demit office upon attaining the age of 65 years or upon the completion of 4 years, whichever is earlier; the person recommended must at least have a minimum tenure of 3 years;
- b. The person should be of outstanding merit and impeccable integrity.

03. While the names of persons are forwarded by different Ministries/ Administrative Departments, a note containing reasons why in the opinion of the forwarding/ sponsoring authority the person is considered to be suitable for appointment as a Chief Vigilance Commissioner/ Vigilance Commissioner including merit and integrity, may be briefly outlined. In addition to the above, the following information may be made available:-

- a. The complete curriculum vitae, including age, educational qualification and details of all posts held by the officer since the beginning of his/ her career;
- b. Service record, namely, Annual Confidential Reports;
- c. Any additional record indicating conferment of honours/ awards/ additional qualifications/ outstanding achievement;
- d. Details of punishment, if any, awarded in the course of officer's service career;
- e. The Ministries/ Departments would also indicate whether there exist any criminal cases/ disciplinary proceedings against the officer concerned
- f. An integrity certificate to be issued by the cadre controlling authority
- g. Vigilance clearance report from existing Vigilance Organization or the Commission.

04. While sponsoring names of persons, names of persons of known impartiality may be forwarded for consideration.



05. In order to ensure that full details are available, no applications will be entertained by the General Administration Department directly from any applicant under any category.

06. It is clarified that while sponsoring names, endeavors may be made that names of persons belonging to all the categories, if available, are forwarded.


